Minutes of Last Meeting The minutes of the meeting held on 20 th January 2016 were agreed.	
Matters Arising J Bouch reported that Top Print have quoted a price of £11.02 per tee-shirt with a one off set up cost of £25.00. It was agreed to supply the logo and arrange for these shirts to be produced.	
Chair's Report Chair pointed out that the stress testing on grave stones had been carried out by WBC and has resulted in a large number of memorial stones being 'tagged' unstable. This matter to be tabled at the next meeting	
Correspondence A letter had been received from a member of the Richards family giving a donation of £65.50 in memory of the three brothers buried in the cemetery. Bank details have been given to them and a 'Thank you' and will be sent. A conference named 'The Beautiful Burial Ground' is to be held at Croxteth Country Park on 13 th April 2016. T Wood and J Bouch to attend at a cost of £15 each. It was agreed unanimously for this to be paid for from the Group's funds.	
War Memorial Wall Following discussion it was agreed to approach Stone Central to see if it is feasible to render the dwarf wall in a similar material to that used on the restored War Memorial. The cost will be covered from the funds raised for the fourth plaque on the War Memorial which cannot go ahead.	JB
Memorial for Unmarked Graves Confirmation has been received from St Mary's Church granting permission to erect this memorial but requesting a £128 fee. J Bouch has already contacted the Church to see if they will agree to

A discussion took place and it was agreed that we ask for a new quotation to reduce the depth of the stone to 6" from 8" and to add the following words to the plinth: Emily Goulden 3rd July 1881 – aged 1 ½ years. First to be buried in this cemetery – also unmarked. J Bouch to contact R Patton regarding this matter.</p>	<p>JB</p>
